In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The right granted herein is limited to the amount which can be applied to beneficial use and shall not exceed 12.6 CFS measured at the point of diversion from Collector 1.

Upon perfecting a subsequent portion of permit S-40336, this certificate shall be cancelled and superseded with a certificate that authorizes a maximum rate of diversion at each point of diversion that is the lesser of: (a) the full rate of water authorized under permit S-40336, (b) the maximum rate at which water can be diverted for beneficial use or, (c) the amount of actual beneficial use.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).
