CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LEN AND KAREN DAMEROW
 3154 VIEW CIRCLE
 CENTRAL POINT, OR 97502

confirms the right to use the waters of EVANS CREEK, a tributary to the ROGUE RIVER, for IRRIGATION OF 8.3 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the Water Resources Director in VOLUME 16, PAGE 523. The date of priority is 1902.

The amount of water to which this right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINTS OF DIVERSION:

The point of diversion is located as follows:

This certificate is issued in accordance with OAR 690-380-6010 to describe the water right for a non-completed additional point of diversion approved by of an order of the Water Resources Director entered 3 March, 2016, at Special Order Volume 98, Page 935, supersedes Certificate 48142, State Record of Water Right Certificates.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
