confirms the right to use the waters of APPLEGATE RIVER, TRIBUTARY TO ROGUE RIVER for IRRIGATION of 61.9 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 523. The date of priority is 1906.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.23 CUBIC FEET PER SECOND.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain and operate an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted as required by the Department.

This certificate is issued to confirm a change in the point of diversion approved by an order of the Water Resources Director entered November 6, 2007, at Special Order Volume 73, Page 597, approving Transfer Application 9298, and together with Certificate 83489, supersedes Certificate 32879, State Record of Water Right Certificates.
