This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Special Volume 4, Page 1. The date of priority is 1894.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.03 CUBIC FEET PER SECOND.

The water user shall maintain and operate the fish screen, as appropriate, at the point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

The water user shall maintain a headgate to control and regulate the quantity of water diverted as required by the Department.

The water user shall maintain and operate an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted as required by the Department.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
