CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALICEL IRRIGATION DISTRICT
64841 IMBLER ROAD
COVE, OR 97824

confirms the right to use the waters of GRANDE RONDE RIVER, a tributary of SNAKE RIVER, for SUPPLEMENTAL IRRIGATION of 74.1 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 1, Volume 8, at Page 1. The date of priority is JUNE 1865.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed THREE ACRE FEET PER ACRE in any irrigation season, diverted at a rate of not to exceed ONE-FORTIETH OF A CUBIC FOOT PER SECOND PER ACRE if available at the original points of diversion described below as Caviness and May Water Ditches.

The points of diversion are located as follows:

A description of the place of use is as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted at each point of diversion.

The water user shall report total flow figures when requested by the Watermaster. The Watermaster may operate the headgate and monitor accuracy of the measuring device, as needed.

Water shall be acquired from the same surface source as the original point of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of diversion shall not exceed the quantity of water available from the original points of diversion as described as follows:

Fifty percent of the quantity of water available from the original points of diversion is subordinated to those existing water rights with authorized points of diversion located within the following reach of the Grand Ronde River:

Upper Reach Boundary:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The right is limited to any deficiency in the available supply of any prior right existing for the same land.

This certificate is issued to confirm changes in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered APRIL 24, 2009, at Special Order Volume 77, Page 596, approving Transfer Application 9008, supersedes Certificate 79875, State record of Water Right Certificates.
