confirms the right to use the waters of TWO WELLS, in the PUDDING RIVER BASIN, for IRRIGATION OF 306.7 ACRES.

This right was perfected under Permit G-5083. The date of priority is June 19, 1970. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.14 cubic feet per second, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acres feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered March 19, 1998, at Special Order Volume 52, Page 196, approving Transfer Application 7593, and supercedes Certificate 47676, State record of Water Right Certificates.
