The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of appropriation from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WELL 3 AND WELL 4, TRIBUTARIES OF THE CHRISTMAS VALLEY BASIN

PURPOSE or USE: QUASI-MUNICIPAL USE

MAXIMUM RATE: 0.25 CUBIC FOOT PER SECOND

DATE OF PRIORITY: AUGUST 12, 1963

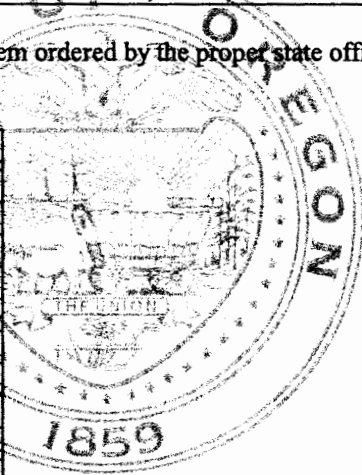

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of appropriation (wells), shall not exceed the quantity of water lawfully available from the original point(s) of appropriation.


When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered January 8, 1996, at Special Order Volume 50, Page 5, approving Transfer Application 7225, supercedes T-5751 (Special Order Volume 40 Page 303) and Certificate 36771, State record of Water Right Certificates.
