CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-42203. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the points of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: JOHN DAY RIVER, A TRIBUTARY OF THE COLUMBIA RIVER

PURPOSE or USE: PRIMARY IRRIGATION OF 14.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 73.8 ACRES

MAXIMUM RATE: 1.29 CUBIC FEET PER SECOND (CFS), BEING 0.35 CFS FOR PRIMARY IRRIGATION AND 0.94 CFS FOR SUPPLEMENTAL IRRIGATION

DATE OF PRIORITY: MAY 4, 1977

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 5.0 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
