CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-12966. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: BEAVER CREEK, A TRIBUTARY OF CROOKED RIVER

PURPOSE or USE: IRRIGATION OF 13.3 ACRES

MAXIMUM RATE: 0.17 CUBIC FOOT PER SECOND

DATE OF PRIORITY: FEBRUARY 23, 1938

The point of diversion is located as follows:

17 S	22 E	WM	14	NE NE	600 FEET SOUTH AND 150 FEET WEST FROM NE CORNER, SECTION 14

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system as may be ordered by the proper state officer.


**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described and is subject to all other conditions and limitations contained in Certificate 24056 and any related decree.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered June 23, 2004, at Special Order Volume 60, Page 356, approving Transfer Application 6693, and together with Certificate 80613, supercedes Certificate 24056, State record of Water Right Certificates.
