CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DARYL FISHER 23060 SW DEJONG RD SHERIDAN OR 97378

confirms the right to use the waters of SOUTH YAMHILL RIVER, tributary of the YAMHILL RIVER for IRRIGATION of 60.8 ACRES.

This right was perfected under Permit S-46693. The date of priority is JANUARY 7, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.76 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, together with that diversed at the old point of diversion, shall not exceed the quantity of water lawfully available from the original point of diversion described as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of part of the type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water shall be acquired from the same surface water source as the original point of diversion.

The water user shall maintain and operate a fish screen at the point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate is issued to confirm changes in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered JUNE 4, 2003, at Special Order Volume 57, Page 927, approving Transfer Application 9245, together with Certificate 80299, supersedes Certificate 79984, State record of Water Right Certificates.
