## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CLEARWATER DITCH COMPANY 81703 HWY 82 WALLOWA OR 97885

confirms the right to use the waters of SOUTH FORK OF WALLOWA RIVER, tributary of the WALLOWA RIVER, for IRRIGATION of 5.0 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the State Water Board of the State of Oregon in Volume 5, at Pages 155-156. The date of priority is MAY 1897.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.5 acre-feet per acre during any period of 30 days prior to July 31<sup>st</sup> of each year, and thereafter not to exceed 1.0 acre foot per acre during the entire remainder of the irrigation season, if available at the authorized point of diversion: CLEARWATER DITCH

The quantity of water diverted at the new points of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water lawfully available at the original points of the residue (Clearwater Ditch).

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface water source as the original point of diversion.

The appropriator shall record and report total flow figures when requested by the Watermaster.

## NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
