## CERTIFICATE OF WATER RIGHT

confirms the right to the use of waters of AN UNNAMED CREEK AND WALDO LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-2299, tributary to the LITTLE PUDDING RIVER, for IRRIGATION OF 48.0 ACRES.

This right was perfected under Permit S-26454. The date of priority is OCTOBER 21, 1959. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.38 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-2299, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
