CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN T. TEHAN PO BOX 34 SISTERS, OR 97759

confirms the right to use the waters of ONE WELL in the SQUAW CREEK (now known as Whychus Creek) BASIN for IRRIGATION of 8.4 ACRES.

This right was perfected under Permit G-11105. The date of priority is JUNE 22, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.105 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The place of use is located as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

When required by the Department, the water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of amount of ground water withdrawn.

The Department may require water level or pump test results every ten years.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights.
