The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: APPLEGATE RIVER, A TRIBUTARY OF ROGUE RIVER

PURPOSE OR USE: PRIMARY IRRIGATION OF 21.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 3.6 ACRES

MAXIMUM RATE: 0.31 CUBIC FOOT PER SECOND

PERIOD OF USE: APRIL 2 TO OCTOBER 31 OF EACH YEAR

DATE OF PRIORITY: DECEMBER 14, 1954

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 0.48 cubic foot per second, described as follows:

The rights to the use of water from tributary streams entering Applegate River between the existing and proposed points of diversion shall not be subject to the water right which is subject of this right.

When in the judgement of the Watermaster it becomes necessary to install headgates and measuring devices:

That the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the water user is entitled;

That the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir of measuring device be installed under the general supervision of said Watermaster.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to the existing minimum flow policies established by the Water Review Board.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered October 14, 1986 at Special Order Volume 40, Page 427, approving Transfer Application 5793, supercedes Certificate 46561, State record of Water Right Certificates.
