CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R.E. SPROUL
BOX 116
MT VERNON, OR 97865

confirms the right to use the waters of the JOHN DAY RIVER, a tributary to the COLUMBIA RIVER for IRRIGATION of 42.4 ACRES AND SUPPLEMENTAL IRRIGATION of 55.8 ACRES.

This right was perfected under Permit S-27706. The date of priority is AUGUST 28, 1961. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.46 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; the right allowed hereunder for the appropriation of water for lands having a valid prior right shall be limited to the amount necessary to make up any deficiency in water, and the amount allowed herein, together with the amount secured under any other right existing for said lands shall be limited by the duty of water as fixed herein and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
