confirms the right to the use of water perfected under the terms of Permit S-49702. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the points of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-1932, TRIBUTARIES OF THE TUALATIN RIVER

PURPOSE OR USE: IRRIGATION OF 26.1 ACRES

MAXIMUM RATE: 148.0 GALLONS PER MINUTE

DATE OF PRIORITY: MAY 12, 1986

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from reservoir constructed under Permit R-1932, and shall conform to such reasonable rotation system as may be ordered by the proper state officer, provided further water shall not be appropriated during the period from July 31 through September 15 of each year except for stored water.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered APRIL 25, 2011, at Special Order Volume 83, Page 1074, approving Transfer Application 11176, and together with Certificate 87025, supercedes Certificate 68504, State record of Water Right Certificates.
