CERTIFICATE OF WATER RIGHT

This certificate is issued to describe the right identified in the decree for the use of the waters of ANNA CREEK, TRIBUTARY TO WOOD RIVER for IRRIGATION of 359.24 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Klamath County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at page 269, as modified by order of the Circuit Court on October 5, 1932. The dates of priority are 1900 for 305.2 acres and 1927 for 54.04 acres.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed a total of 4.49 CUBIC FEET PER SECOND (CFS), FURTHER LIMITED TO 3.815 CFS FOR PRIORITY DATE 1900, AND 0.675 CFS FOR PRIORITY DATE 1927, or its equivalent in case of rotation, measured at the point of diversion.

This appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state official.
