CERTIFICATE OF WATER RIGHT

ROBERT AND RUTH WONDRA 665 COUNTY ROAD MILTON-FREEWATER, OR 97862

confirms the right to use the waters of the Walla Walla River, a tributary of the Columbia River, for the purpose of Irrigation of 23.52 acres and Irrigation and Stock use on 0.70 acre.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12, Page 9. The dates of priority are 1875, 1877, 1883, 1885 and 1894.

The use is limited to one miner's inch per acre, or 0.606 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:
