 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARVIN AND BEVERLY SAMS
 53012 COUNTY ROAD
 MILTON-FREEWATER, OR 97862

confirms the right to use the waters of the Walla Walla River, a tributary of the Columbia River, for the purpose of IRRIGATION of 18.11 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12, Page 9. The dates of priority are 1900 and 1905.

The use is limited to one miner's inch per acre, or 0.453 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and the right shall be subject to all other conditions and limitations contained in the above described decree.



A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
