This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12, Page 9. The dates of priority are 1890, 1891, and 1895.

The use is limited to one miner's inch per acre, or 0.30 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the source.
