CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CINDER BUTTE INC.
PO BOX 5
PRINCETON, OR 97721

confirms the right to use the waters of THREE WELLS in the MALHEUR SLOUGH BASIN for the purpose of PRIMARY IRRIGATION OF 266.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 98.5 ACRES.

This right was perfected under Permit G-8161. The date of priority is JANUARY 25, 1978. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 4.56 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


