confirms the right to the use of water perfected under the terms of Permit S-37121. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: COLUMBIA RIVER, TRIBUTARY TO THE PACIFIC OCEAN

PURPOSE OR USE: IRRIGATION OF 42.1 ACRES

MAXIMUM RATE: 0.7 CUBIC FOOT PER SECOND, BEING 0.55 CFS FOR OCTOBER 3, 1973, AND 0.15 CFS FOR DECEMBER 11, 1973

DATE OF PRIORITY: OCTOBER 3, 1973, DECEMBER 11, 1973

The point of diversion is located as follows:

5 N	30 E	WM	8	SW NW	2910 FEET NORTH AND 120 FEET EAST FROM SW CORNER, SECTION 8

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered June 1, 2011, at Special Order Volume 84, Page 361, approving Transfer Application 11170, and together with Certificate 87050, supersedes Certificate 86127, State record of Water Right Certificates.
