confirms the right to the use of water perfected under the terms of Permit G-10355. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: A WELL IN THE COLUMBIA RIVER BASIN

PURPOSE OR USE: MUNICIPAL USE

MAXIMUM RATE: 80.0 GALLONS PER MINUTE

DATE OF PRIORITY: AUGUST 15, 1983

The well is located as follows:

A description of the place of use is as follows:

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water used, as approved by the Department.

The water user shall report by December 31 of each year, a report detailing monthly water use under each right from each point of appropriation. Reporting shall be for the previous water year. The Watermaster may operate the controlling device and monitor the accuracy of the measuring device, as needed.

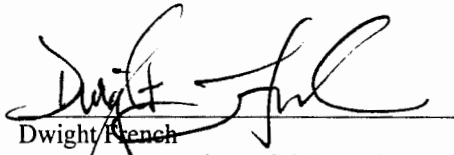
The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in CHARACTER OF USE approved by an order of the Water Resources Director entered DECEMBER 9, 2003, at Special Order Volume 58, Page 277, approving Transfer Application 7822, and supercedes Certificate 63612, State record of Water Right Certificates.
