CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOST AND BOULDER DITCH COMPANY
PO BOX 12
WAMIC OR 97063

confirms the right to the use of waters of LOST AND BOULDER CREEKS, tributaries of the WHITE RIVER, for IRRIGATION AND SUPPLEMENTAL IRRIGATION OF 10.0 ACRES, DOMESTIC, AND STOCK IN TRACT 1, IRRIGATION AND SUPPLEMENTAL IRRIGATION OF 29.5 ACRES IN TRACT 2.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 196, and Volume 11, at Page 416. The dates of priority are 1901 FOR TRACT 1 AND 1911 FOR TRACT 2.

The amount of water to which this right is entitled, in combination with other rights describing portions of Certificate 34533, is limited to an amount actually beneficially used, and shall not exceed:

TRACT 1 – 7.0 CUBIC FEET PER SECOND MEASURED AT OR NEAR THE DIVERSION BOX AT THE HEAD OF THE MAIN LATERALS OF SAID COMPANY SITUATED IN THE NE1/4 SW1/4, SECTION 10, TOWNSHIP 5 SOUTH, RANGE 11 EAST, W. M.

TRACT 2 - SHALL BE LIMITED TO A DIVERSION OF NOT TO EXCEED 1.0 ACRE-FOOT PER ACRE DURING ANY 30 DAY PERIOD UP TO JULY 1 OF EACH YEAR AND NOT TO EXCEED 3.0 ACRE-FEET PER ACRE DURING ANY IRRIGATION SEASON, PROVIDED THAT THE RATE OF FLOW SHALL NOT EXCEED ONE-FORTIETH OF A SECOND FOOT PER ACRE UP TO JULY 1 OF EACH YEAR AND THEREAFTER NOT TO EXCEED ONE-EIGHTIETH OF A SECOND FOOT PER ACRE;

or its equivalent in case of rotation, measured at the point of diversion.


NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered January 18, 1982, at Special Order Volume 35, Page 513, approving Transfer Application 4913, and together with Certificate 80559, supersedes Certificate 34533, State record of Water Right Certificates.
