confirms the right to the use of water perfected under the terms of Permit G-10279. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the wells. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WELL #1 AND WELL #2 IN THE LITTLE DESCHUTES RIVER BASIN

PURPOSE OR USE: IRRIGATION OF 4.5 ACRES

MAXIMUM RATE: 0.056 CUBIC FOOT PER SECOND

DATE OF PRIORITY: SEPTEMBER 13, 1983

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new points of appropriation (wells), together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.

Water shall be acquired from the same aquifer as the original point of appropriation.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Measurement conditions:

- A. The water user shall maintain the meters or measuring devices in good working order.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in ADDITIONAL POINT OF APPROPRIATION AND PARTIAL CANCELLATION OF A WATER RIGHT approved by an order of the Water Resources Director entered April 17, 2014, at Special Order Volume 92, Page 227, approving Transfer Application 11488, and together with Certificate 89227, supercedes Certificate 64253, State record of Water Right Certificates.
