confirms the right to use the waters of JOHN DAY RIVER, TRIBUTARY TO THE COLUMBIA RIVER for IRRIGATION of 93.3 ACRES AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1866.

The point of diversion is located as follows:

The use is limited to ONE-FORTIETH cubic foot per second per acre irrigated from April 1 to September 30; further limited to one acre-foot per acre per calendar month to July and ¾ acre-foot per acre thereafter; total five acre-feet per acre for season, or its equivalent in case of rotation measured at the point of diversion from the source.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface water source as the original points of diversion
