CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-11478. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: A SPRING, A TRIBUTARY OF AN UNNAMED STREAM

PURPOSE OR USE: STOCK, DOMESTIC USE FOR ONE FAMILY, AND IRRIGATION of 1.0 ACRE

MAXIMUM RATE: 0.028 CUBIC FOOT PER SECOND (CFS); BEING 0.01 CFS FOR STOCK, 0.005 CFS FOR DOMESTIC USE, AND 0.013 FOR IRRIGATION

DATE OF PRIORITY: OCTOBER 30, 1934

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.
