## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

O.M. THOMPSON & M.C. THOMPSON SHEDD, OREGON

confirms the right to use the waters of the CALAPOOIA RIVER, a tributary of WILLAMETTE RIVER for DEVELOPMENT OF 115.34 THEORECTICAL HORSEPOWER (not electrical).

This right was perfected under Permit S-10918. The date of priority is JULY 1, 1933. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 143.0 CUBIC FEET PER SECOND measured at the point of diversion from the stream.

The point of diversion is located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent in case of rotation.

A description of the lands irrigated under the right hereby confirmed, and to which such right is appurtenant (if for irrigation, or any other purpose), is as follows:

This certificate describes that portion of the water right confirmed by Certificate 10766, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered Sept. 2016, approving Transfer Application T-11753.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

After the expiration of fifty years from the original date of this certificate (May 8, 1934) or on the expiration of any federal power license issued in connection with this right, and after not less than two

years notice in writing to the holder hereof, the State of Oregon, or any municipality thereof, shall have the right to take over the dams, plants and other structures and all appurtenances thereto which have been constructed for the purpose of devoting to beneficial use the water rights specified herein, upon condition that before taking possession the State or municipality shall pay not to exceed the fair values of the property so taken, plus such reasonable damages, if any, to valuable, serviceable and dependable property of the holder of this certificate, not taken over, as may be caused by the severance therefrom of the property taken in accordance with the provisions of section 47-508, Oregon Code 1930.
