confirms the right to the use of water perfected under the terms of Permit S-24144. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: BIRCH CREEK AND UMATILLA RIVER, TRIBUTARIES TO THE COLUMBIA RIVER

PURPOSE or USE: IRRIGATION OF 5.7 ACRES

MAXIMUM RATE: 0.14 CUBIC FOOT PER SECOND, WATER TO BE DIVERTED FROM BIRCH CREEK WHEN AVAILABLE AND ANY DEFICIENCY IN THE AVAILABLE SUPPLY IN BIRCH CREEK IS TO BE MADE UP BY THE DIVERSION FROM UMATILLA RIVER, PROVIDING THAT THE TOTAL QUANTITY DIVERTED FROM BOTH STREAMS SHALL NOT EXCEED ONE-FORTIETH CUBIC FOOT PER SECOND FOR EACH ACRE IRRIGATED, IF AVAILABLE AT THE AUTHORIZED POINTS OF DIVERSION.

DATE OF PRIORITY: APRIL 5, 1956

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre and shall be further limited to a diversion of not to exceed 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
