confirms the right to the use of water perfected under the terms of Permit G-9854. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the wells. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WELLS #2 AND #3 IN THE UMATILLA RIVER BASIN

PURPOSE OR USE: DOMESTIC USE FOR 29 FAMILIES INCLUDING THE IRRIGATION OF UP TO ONE-HALF ACRE LAWN AND NON-COMMERCIAL GARDEN FOR EACH

MAXIMUM RATE: 0.07 CUBIC FOOT PER SECOND

DATE OF PRIORITY: APRIL 2, 1982

The wells are located as follows:

5 N	28 E	WM	34	SE NE	WELL #2 (ORIGINAL) - 260 FEET NORTH AND 630 FEET WEST FROM E1/4 CORNER, SECTION 34
5 N	28 E	WM	34	SE NE	WELL #3 (ADDITIONAL) - 230 FEET NORTH AND 80 FEET WEST FROM E1/4 CORNER, SECTION 34

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

Twp	Rng	Mer	Sec	Q-Q
5 N	28 E	WM	34	SE NE

Water from the new well shall be acquired from the same aquifer (water source) as the original point of appropriation.

The quantity of water diverted at the additional point of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.

The water user shall maintain and operate the measuring device as required by the Department.


**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered July 13, 2007, at Special Order Volume 72, Page 629, approving Transfer Application 10236, supercedes Certificate 63693, State record of Water Right Certificates.
