CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-3438. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the points of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: DESCHUTES RIVER, A TRIBUTARY OF THE COLUMBIA RIVER

PURPOSE OR USE: MUNICIPAL USE, RESTRICTED FURTHER TO NON-POTABLE HUMAN CONSUMPTIVE USES ONLY

MAXIMUM RATE: 0.09 CUBIC FOOT PER SECOND

PERIOD OF USE: APRIL 1 THROUGH NOVEMBER 1 OF EACH YEAR

DATE OF PRIORITY: JULY 19, 1917

The point of diversion is located as follows:

16 S	12 E	WM	29	NW SW	520 FEET SOUTH AND 890 FEET EAST FROM W1/4 CORNER, SECTION 29

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:

Twp	Rng	Mer	Sec	Q-Q
16 S	12 E	WM	29	NW SW
16 S	12 E	WM	30	NE SE

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface water source as the original point of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW


This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.

This certificate is issued to confirm a change in CHARACTER OF USE AND PLACE OF USE approved by an order of the Water Resources Director entered July 2, 2002, at Special Order Volume 56, Page 623, approving Transfer Application 6821, supercedes Certificate 45382, State record of Water Right Certificates.
