CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON  
WATER RESOURCES DEPARTMENT

confirms the right to use the waters of CALAPOOIA RIVER, a tributary to the WILLAMETTE RIVER, for INSTREAM USE for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat, and other ecological values, and pollution abatement.

This right was perfected under Permit S-50103. The date of priority is SEPTEMBER 22, 1987. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.02 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion, from JUNE 2 TO SEPTEMBER 30, further limited to an annual volume of 4.84 ACRE-FEET.

The description of the stream point in which flows are to be maintained is the location of the diversion authorized previously under Certificate 65680, as follows:

Water rights upstream of the original point of diversion shall not be subject to regulation for flows in excess of the quantities to which this instream water right is entitled at the original point of diversion.

The amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original point of diversion.

The instream right established by this transfer shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights established pursuant to ORS 537.346, 537.348 or 537.470, unless otherwise specified by a subsequent order establishing a new instream water right.

The right is subject to all other terms and conditions of Certificate 65680, and any related decree.

This certificate is issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director recorded in Special Order Volume 103, Page ~~273~~, approving Conserved Water Application CW-91. This Certificate together with Certificates 91925 and 91926 supersedes Certificate 65680, State Record of Water Right Certificates.
