CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HOWARD W. PEALER GRANTS PASS, OR 97526

confirms the right to use the waters of the DRAIN, a tributary to the ROGUE RIVER for IRRIGATION of 20.25 ACRES and SUPPLEMENTAL IRRIGATION of 3.75 ACRES.

This right was perfected under Permit S-11261. The date of priority is MAY 15, 1934. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.30 CUBIC FOOT PER SECOND (CFS), being 0.25 CFS for primary irrigation and 0.05 CFS for Supplemental Irrigation measured at the point of diversion from the stream, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to diversion of ONE-EIGHTIETH of one cubic foot per second per acre.
