## CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-24819. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the points of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WILLAMETTE RIVER, TRIBUTARY TO COLUMBIA RIVER

PURPOSE OR USE: IRRIGATION OF 28.4 ACRES

MAXIMUM RATE: 0.36 CUBIC FOOT PER SECOND

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

## NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional points of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water lawfully available from the original points of diversion.

When required by the Department, the water user shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain fish screens or fish by-pass devices, as appropriate, at the new points of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in CHARACTER OF USE AND ADDITIONAL POINTS OF DIVERSION approved by an order of the Water Resources Director entered OCTOBER 20, 2005, at Special Order Volume 67, Page 332, approving Transfer Application 7126, and together with Certificate 81567, supercedes Certificate 31710, State record of Water Right Certificates.
