 CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL, in the SOAP CREEK BASIN for DOMESTIC USE FOR 44 FAMILIES INCLUDING THE IRRIGATION OF ONE-HALF ACRE LAWN AND NON-COMMERCIAL GARDEN FOR EACH FAMILY.

This right was perfected under Permit G-10673. The date of priority is APRIL 29, 1986 – FOR 0.016 CUBIC FOOT PER SECOND (CFS) AND OCTOBER 10, 1986 – FOR 0.114 CFS. This right is limited to 0.13 CFS or its equivalent in case of rotation, measured at the well.

The well is located as follows:

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The water user shall install and maintain a weir, meter, or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued in accordance with OAR 690-380-6010 to describe the water right for a non-completed change in point of appropriation approved by an order of the Water Resources Director entered October 21, 2016, at Special Order Volume 103, Page 236, supersedes Certificate 77016, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
