CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MAPLE CREEK, tributary to COW CREEK and COW CREEK is a tributary to SOUTH UMPQUA RIVER for PRIMARY (MAPLE CREEK) and SUPPLEMENTAL (COW CREEK) IRRIGATION OF 10.3 ACRES; AND SUPPLEMENTAL IRRIGATION (COW CREEK) OF 7.6 ACRES.

This right was perfected under Permit S-41570. The date of priority is October 11, 1976 for Cow Creek and June 8, 1977 for Maple Creek.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.256 CUBIC FOOT PER SECOND (CFS), BEING 0.13 CFS FROM MAPLE CREEK WITH ANY DEFICIENCY IN THE SUPPLY TO BE APPROPRIATED FROM COW CREEK PROVIDED THE TOTAL QUANTITY OF WATER SHALL NOT EXCEED 0.146 CFS; 0.11 CFS SUPPLEMENTAL IRRIGATION FROM COW CREEK, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SEVENTIETH of one cubic foot per second, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.



When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JUNE 30, 2005 at Special Order Volume 65, Page 266, approving Transfer Application 9470, and together with Certificate 81527, supersedes Certificate 75262, State Record of Water Right Certificates.
