## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARCIA C. RODINE 745 ALASKA ST ASHLAND OR 97520

confirms the right to use the waters of WEST BRANCH OF MAPLE CREEK, TRIBUTARY TO MAPLE CREEK for IRRIGATION of 6.2 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Douglas County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 11, at Page 1. The date of priority is 1887.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed the rate of one cubic foot of water per second of time for each 70 acres of land irrigated during the irrigation season.

The point of diversion is located as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

## NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
