CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JACK SMITH
 STAR ROUTE BOX 50
 ST PAUL, OR 97137

confirms the right to use the waters of a WELL in the MISSION CREEK BASIN for IRRIGATION of 111.7 ACRES and SUPPLEMENTAL IRRIGATION OF 153.7 ACRES.

This right was perfected under Permit G-2544. The date of priority is FEBRUARY 7, 1964. The amount of water to which this right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.3 CUBIC FEET PER SECOND (CFS) being 0.55 CFS for PRIMARY IRRIGATION and 0.75 CFS for SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
