The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The water user shall maintain and operate fish screening and by-pass device, as appropriate, at the point of diversion consistent with the Oregon Department of Fish and Wildlife's operational and maintenance standards.

The water user shall maintain and operate the measuring device as required by the Department.

When required by the Department, the water user shall install, maintain, and operate a headgate to control and regulate the quantity of water diverted. The types and plans of the headgate must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered August 1, 2007, at Special Order Volume 73, Page 18, approving Transfer Application T-8126, and together with Certificate 83397, supercedes Certificate 19989, State record of Water Right Certificates.
