confirms the right to use the waters of ROCK CREEK, TRIBUTARY TO POWDER RIVER for IRRIGATION OF 73.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at Page 291. The date of priority is 1882.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed ONE-FORTIETH of one cubic foot per second per acre, if available at the authorized point of diversion: OWEN DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source, and is subject to all other conditions and limitations contained in said decree.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
