## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to the use of water perfected under the terms of Permit G-7170. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the wells. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: THREE WELLS IN THE FORT ROCK BASIN

PURPOSE OR USE: IRRIGATION OF 354.7 ACRES

MAXIMUM RATE: 3.5 CUBIC FEET PER SECOND (CFS), BEING 2.1 CFS FROM WELL 5, 0.7 CFS FROM WELL 6,

AND 0.7 CFS FROM WELL 7

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- a. The water user shall maintain the meters or measuring devices in good working order.
- b. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in POINTS OF APPROPRIATION AND PLACE OF USE approved by an order of the Water Resources Director entered October 3, 2012, at Special Order Volume 88, Page 603, approving Transfer Application 11405, and together with Certificate 87788, supercedes Certificate 80753, State record of Water Right Certificates.
