CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHESTER VOSS 14855 CHISPA RD ATASCADERO CA 93422

confirms the right to use the waters of JOHN DAY RIVER, A TRIBUTARY OF COLUMBIA RIVER for IRRIGATION of 24.8 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County as evidenced by an order of the Water Resources Director, entered July 21, 1998, at Special Order Volume 52, Page 685, approving Transfer 7401. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1887.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.62 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed ONE-FORTIETH of one cubic foot per second per acre irrigated from April 1 to September 30; further limited to one acre-foot per acre per calendar month to July 1 and 3/4 acre-foot per acre thereafter; total 5.0 acre-feet per acre for season, measured at the points of diversion.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface water source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm a change in ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered December 6, 2001, at Special Order Volume 55, Page 1295, approving Transfer Application 8533, and together with Certificate 68542, supercedes Certificate 39362, as modified by T-7401, at Special Order Volume 52, Page 685.
