CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J F HUTCHINSON  
UNION, OR 97883

confirms the right to use the waters of CATHERINE CREEK, a tributary to the GRANDE RONDE RIVER for IRRIGATION of 60.9 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 1. The date of priority is 1864, FOR TRACT NO 1; 1867, FOR TRACT NO. 2; 1876, FOR TRACT NO 3. The use is limited to 1.52 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent not to exceed 3 acre-feet, for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to correct a scrivener's error in the description of the source stream described on Certificate 72293. This Certificate supersedes Certificate 72293, and describes the portion of water right Certificate 36609, NOT modified by the provisions of an order of the Water Resources Director entered July 30, 1996, and recorded at Volume 50, Page 517, approving Transfer Application T-7450.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
