This right was perfected under by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12 at Page 9. The priority dates are 1871, 1881, 1886, 1890, 1891, 1893, 1894, 1898, 1901, 1904, 1905, and 1908.

The use is limited to 1.5 MINER'S INCHES PER ACRE, or 2.68 cubic feet per second, or its equivalent in case of rotation, measured at the point of diversion from the source.
