confirms the right to use the waters of the Little Walla Walla River, tributary to the Walla Walla River for IRRIGATION on 53.91 ACRES.

This right was perfected under by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12 at Page 9. The priority dates are 1878, 1879, 1885, 1888, 1889, 1891, 1893, 1902, 1905, and 1906.

The use is limited to 1.5 MINER'S INCHES PER ACRE, or 2.024 cubic feet per second, or its equivalent in case of rotation, measured at the point of diversion from the source.
