CERTIFICATE OF WATER RIGHT

A and K Estates, LLC 1812 10th Ave E. Seattle, WA 98102-4215

confirms the right to use the waters of the Little Walla Walla River, tributary to the Walla River for IRRIGATION on 18.37 ACRES and SUPPLEMENTAL IRRIGATION on 18.37 ACRES.

This right was perfected under Permit S-1216 and S-26001. The priority dates are MARCH 25, 1912 for IRRIGATION and JANUARY 16, 1959 for SUPPLEMENTAL IRRIGATION. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.693 cubic foot per second (cfs), being 0.232 cfs for IRRIGATION and 0.461 cfs for SUPPLEMENTAL IRRIGATION, or its equivalents in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, for IRRIGATION is limited to ONE-EIGHTIETH (1/80) of one cfs per acre, and for SUPPLEMENTAL IRRIGATION is limited to 0.0375 cfs (3/80) per acre, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.
