 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

confirms the right to use the waters of the Little Walla Walla River, tributary to the Walla Walla River for IRRIGATION on 3.1 ACRES and SUPPLEMENTAL IRRIGATION on 3.1 ACRES.

This right was perfected under Permits S-1216 and S-26001. The priority dates are MARCH 25, 1912 for IRRIGATION and JANUARY 16, 1959 for SUPPLEMENTAL IRRIGATION. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.117 CUBIC FOOT PER SECOND (cfs), being 0.039 cfs for IRRIGATION and 0.078 for SUPPLEMENTAL IRRIGATION or its equivalents in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used under this right, together with the amount secured under any other right existing for the same lands for IRRIGATION is limited to ONE-EIGHTIETH of one cfs per acre, and for SUPPLEMENTAL IRRIGATION is limited to 0.375 cfs (3/80) per acre, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes the water right confirmed by Certificates 86961 (90699) and 86964 (90700), , State Record of Water Right Certificates, modified by the provisions of an order of the Water Resources Director entered MAY - 5 2017, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificates 86961 (90699) and 86964 (90700).
