 CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of Little Walla Walla River, tributary to the Walla Walla River for IRRIGATION on 40.0 ACRES.

This right was perfected under Permits S-8193 and E-170. The priority dates are OCTOBER 5, 1927 AND MAY 3, 1913. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.468 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:

Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water Right Certificates, modified by the provisions of an order of the Water Resources Director entered MAY - 5 2017, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificates 76330 and 84159.
