The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.357 cubic foot per second (cfs), being 0.117 cfs for IRRIGATION and 0.240 cfs for FROST PROTECTION, or their equivalents in case of rotation, measured at the point of diversion from the source.
