CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TWO WELLS, tributary to the Walla River for SUPPLEMENTAL IRRIGATION on 37.75 ACRES.

This right was perfected under Permit G-4580. The priority date is 5/6/1969. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.474 cubic foot per second (cfs), being 0.237 cfs from each of the two wells, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 4.5 acre-feet per acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.
